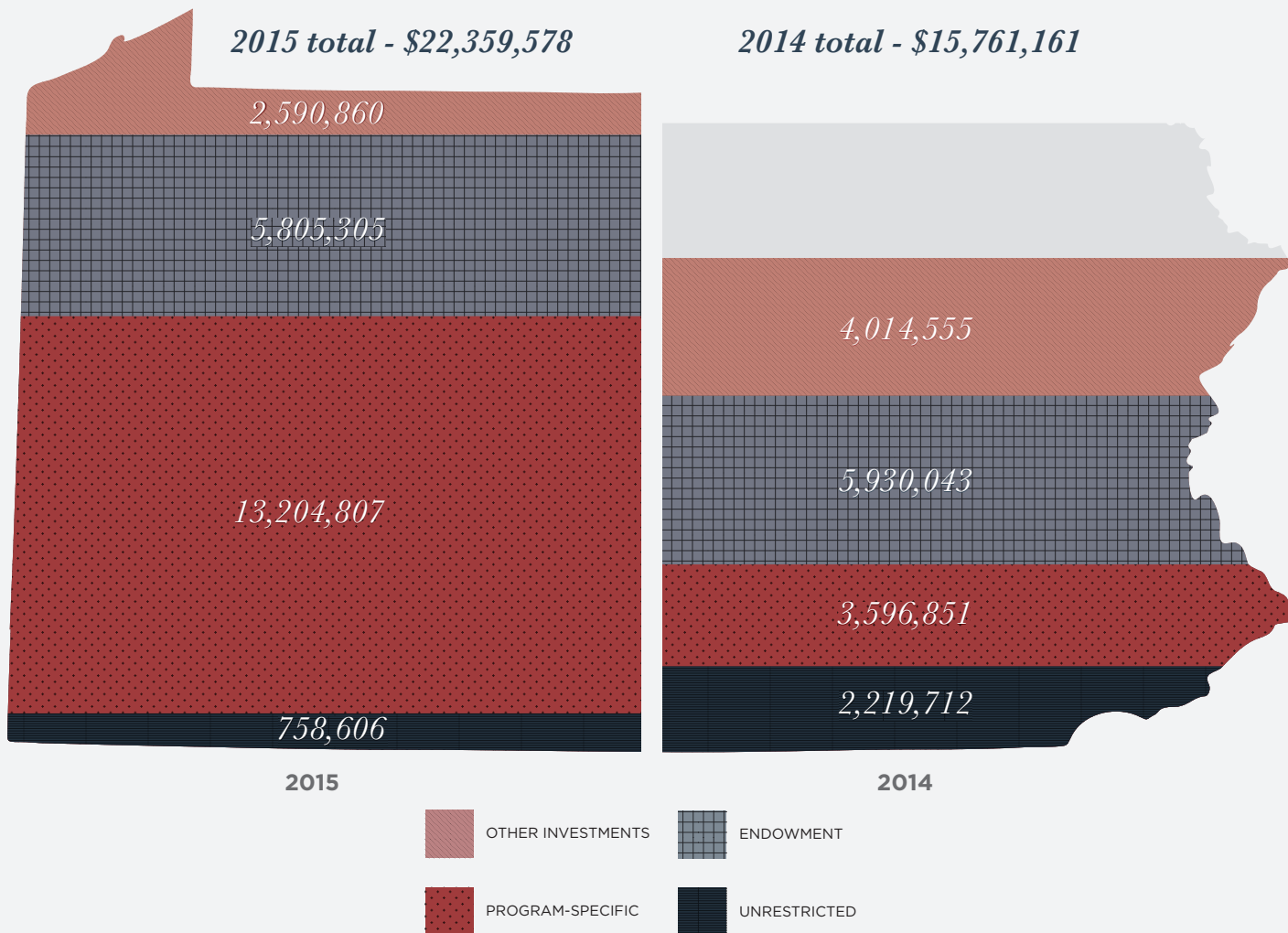
During a year of transition, Team Pennsylvania is moving forward – building on our past successes and looking ahead to the needs of the commonwealth.
